

ESTABLISH ATTENDANCE AREA FOR THE NEW DAVIS-SHIELDS SCHOOL AND ADJUST ATTENDANCE AREA BOUNDARY OF THE NATHAN DAVIS ELEMENTARY SCHOOL.

Establish the attendance area for the new Davis-Shields elementary school located at 3014 West 39th Place and of James Shields elementary school located at 4260 South Central Street. Applicable to all students, except eighth graders, effective July 1, 2001 and to all students effective July 1, 2002.

Changes are necessary due to the opening of the New Davis-Shields School, to reduce overcrowding at the James Shields school and at the Nathan Davis School. Reducing the overcrowding is accomplished by reassigning students from the Shields and Davis attendance areas to the new school.

The Comprehensive Student Assignment Plan, adopted by the Board of Education on January 22, 1982 (Board Report 82-22), states: "The Board will seek to eliminate overcrowded schools to the greatest extent practical under the circumstances."
