

APPROVE ENTERING INTO A LICENSE AGREEMENT WITH UNION LEAGUE BOYS AND GIRLS CLUBS FOR THE USE OF SPACE AT VON HUMBOLDT ELEMENTARY SCHOOL

In lieu of a fee for the use of space of Von Humboldt, the Union League Boys and Girls Clubs agrees to the following in-kind provisions:

- Provide the needed staff to control space utilized by the Union League Boys and Girls Club
Provide supervision of the building and structure for staff to ensure proper control of areas occupied by the Union League Boys and Girls Club
Provide computers to Von Humboldt for use during and after school hours
Provide compression equipment (portable, preferably) for use in the building
Provide security guard services during the hours that the Union League Boys and Girls Club occupies the building
