Consultant Software Licensor was selected on a non-competitive basis based upon company's proprietary workflow software and experience with electronic workflow management analysis for the Board of Education. A written license and consulting agreement for such software product and systems and web-based solutions. Software upgrades and bug fixes will be provided free of charge and services is currently being estimated time to complete the consulting services for board customization for the next six months.

Final written agreement shall be rendered and no payment shall be made to Consultant Software Licensor prior to the execution of the final written agreement. Consultant Software Licensor shall automatically establish business terms and conditions of this agreement is not executed within sixty (60) days of the date of this Board Report. Informal agreement is stated below.

This amendment is necessary to amend the Consultant's scope of services to (1) include additional services for the development of an automated board report process and (2) include Consultant's services for licenses and support. The original written agreement has not yet been executed. This amendment shall exclude the purchase of software licenses.
