

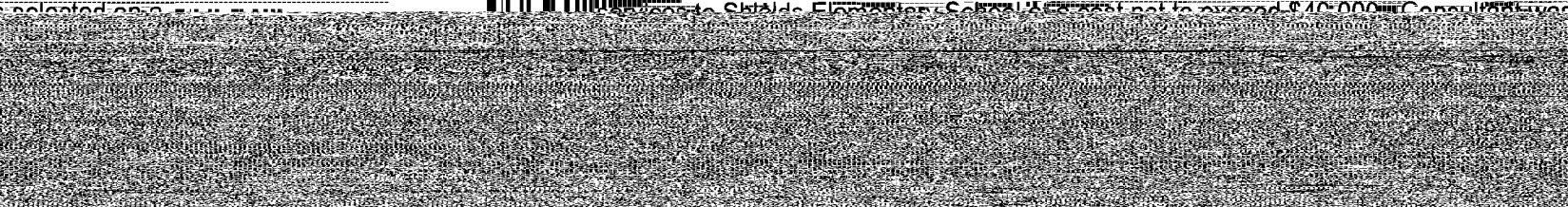
APPROVE ENTERING INTO AN AGREEMENT WITH ADVANCED SYSTEMS CONSULTANT, INC.
