RECOMMENDED DECISION

award of Capital Improvement Program construction contracts in the amount of \$3,99 to the respective lowest responsible bidders for various construction projects, as specified in Appendix A, in accordance with the Board's Capital Improvement Program. Work involves all labor, material and equipment tools, additions, and annexes, or to renovate existing facilities, all as specifications for the respective projects. Proposals, schedules of supporting documents are on file in the Department of Operations. These contracts have been awarded in accordance with the rules and regulations of the Board of Education of the City of Chicago.

Ratify the award of Capital Improvement Program construction contracts in the amount of \$48,692,066 to the respective lowest responsible bidders for various construction projects, as specified in Appendix B, in accordance with the Board's Capital Improvement Program. Work involves all labor, material and equipment tools, additions, and annexes, or to renovate existing facilities, all as specifications for the respective projects. Proposals, schedules of supporting documents are on file in the Department of Operations. These contracts have been awarded in accordance with the rules and regulations of the Board of Education of the City of Chicago.

Ratify changes to existing Capital Improvement Program construction contracts, in the amount of \$712,037.76 as listed in Appendix B of this report. These construction contract changes have been processed and are being submitted to the Board for ratification in accordance with section 7 of the Rules of the Board of Education of the City of Chicago.

GENERAL CONDITIONS:

The agreement will be subject to the Board's financial audit and audit committee review. The Inspector General shall have access to all information and documents relevant to the audit and inspection. The Inspector General shall have the right to inspect and audit any financial transaction or contract entered into by the Board, provided that such inspection or audit does not interfere with the Board's performance of its functions. Indebtedness – The Board's Indebtedness Policy adopted July 26, 1995 (95-07-26-EX3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Contingent Liability – The agreement shall contain the clause that any expenditure beyond the amount necessary to implement the agreement, in the event of a subsequent reappropriation, may be made at the discretion of the Board.




