

RESOLUTION OF THE BOARD OF DIRECTORS OF THE DISTRICT OF COLUMBIA

WHEREAS in Board Report 02-0123-EX4 the Board has approved the proposed expansion of Canter Middle School (Canter) from sixth through eighth grade to seventh and eighth grade;

WHEREAS in Board Report 02-0123-EX4 the Board significantly expanded the attendance boundaries for Brent Harte and William H. Ray Middle School (Canter) from boundaries for Canter to include the attendance boundaries for Brent Harte and William H. Ray Middle School (Canter) and Relish Shoar Smith Elementary School;

WHEREAS the expansion of the attendance boundaries for Canter will allow students from Brent Harte, William H. Ray and Relish Shoar Smith Elementary Schools and students currently attending nonpublic schools but residing within Canter's new attendance boundaries to attend Canter;

WHEREAS in Board Report 02-0123-EX4 the Board also allows students from Murray Language Academy to attend Canter;

WHEREAS the foregoing changes will not be effective until the Fall Term of the 2002-2003 school year;

WHEREAS the foregoing changes will not be effective until the Fall Term of the 2002-2003 school year;

wing community residents within the voting boundaries for Murray Language Academy to participate, as both candidates and electors, in Canter Local School Council elections commencing in the Fall Term of the 2002-2003 school year further contributes to a significant change in the composition, and increase in the size of the population of community residents thereafter eligible to participate, as both candidates and electors, in Canter Local School Council elections;

for Canter on second semester report card pick-up day would deny the parents or legal guardians of all students eligible to attend Canter as seventh-graders in the following Fall Term the opportunity to participate, as both candidates and electors, in any local school council election for Canter until 2004;

WHEREAS, conducting the 2002 local school elections for Canter on second semester report card pick-up day would deny the community residents of Canter's new attendance area and the electors, in any local school council election for Canter until 2004;

WHEREAS, for all of the reasons cited above, the Chief Executive Officer has determined that changing the date of the next local school council election for Canter from report card pick-up day of the second semester of the 2001-2002 school year to report card pick-up of the first both candidates and electors, by the parents and community residents who would be eligible to

WHEREAS, the Board has adopted Board Rule 6-33.0 On a vote of an Attendance Centers Local Council Election, pursuant to its authority under Sections 5/4A-2.1(a) and 5/4A-18

CHICAGO:

1. The date of the next local school council election for Canter Middle School shall be held on the first Tuesday of the second semester of the 2002-2003 school year to November 19, 2002.

2. The candidates elected in the election described in paragraph 1 shall depend upon the results of the election held on the date specified in paragraph 1 and December 1, 2002 immediately following said election.

3. The dates for all succeeding biennial local school council elections for Canter Middle School shall be changed from report card pick-up day of the second semester of every even-numbered year after 2002 school year to report card pick-up of the first semester of every even-numbered year after 2002.
