

**APPROVE ENTERING INTO AGREEMENTS WITH ISBE-APPROVED
SUPPLEMENTAL EDUCATIONAL SERVICE PROVIDERS**

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve entering into agreements with various educational and instructional providers to provide Supplemental Educational Services (SES) to students attending NCLB-eligible schools at a cost not to exceed \$39,000,000. Providers were identified on the *Approved List of Supplemental Educational Service Providers for the 2004-2005 School Year* issued by the Illinois State Board of

Education as required under the *No Child Left Behind Act*. Written master agreements for each Provider's services are currently being negotiated. No services shall be rendered by any Provider and no payment shall be made to any Provider prior to the execution of such Provider's written master agreement. STUDENT ASSIGNMENTS: Parents of students who are eligible under the *No Child Left Behind Act* shall have the right to select any one of the Providers or the Chicago Public Schools to provide supplemental services to their child and notify the Office of After School and Community School Programs of such selection.
