- b. The Law Department; and
- c. The Office of Communications.
- 3. For reports involving a private contractor, notify:
 - a. The OEAS, OHSP, Department Head, as applicable;
 - b. The Law Department; and
 - c. The Office of Communications.

B. <u>District Investigators</u>

1. <u>Investigators from the Law Department or Office of the Inspector General may investigate</u> allegations of child abuse or neglect by employees, volunteers or contractors.



C. Any Illinois teaching or administrative certificate or endorsement may be suspended for a period not to exceed one calendar year by the regional superintendent or for a period not to exceed five calendar
