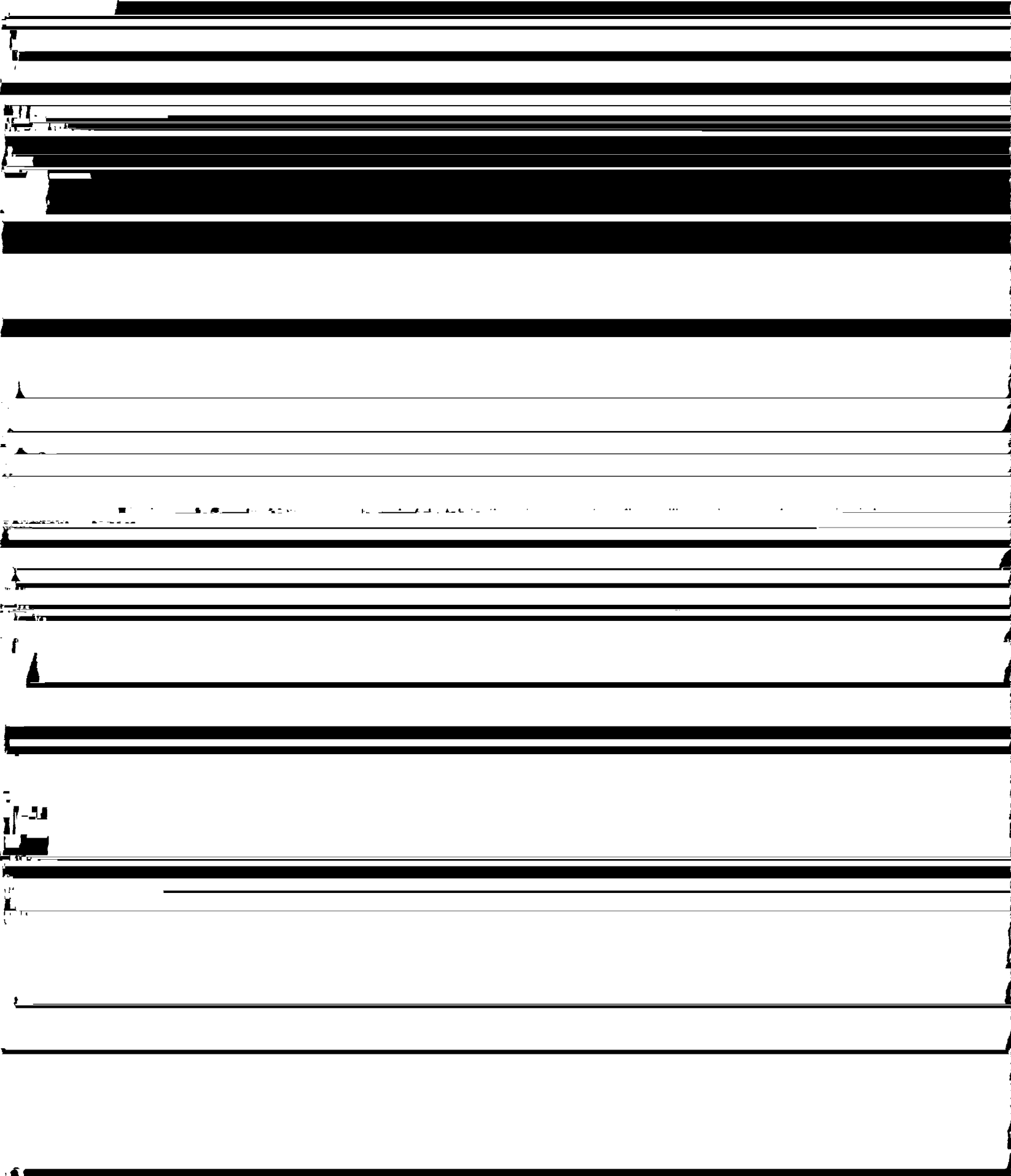
Approve exercising the second option to renew agreements with Vendors identified on the attached list to
