ARTICLE I - NAME AND AUTHORITY

Section 1. Name. The name of this advisory board established by the Chicago Board of Education ("Board") under Board Report 07-0822-RS4, as amended under Board Report 18-1024-RS1 shall be the Title I Parent Board of Governors ("PBG") Parent Involvement Advisory Board ("PIAB").

Section 2. Authority. The PBG PIAB and these by-laws are created to fulfill the obligations of the Every Student Succeede Act (ESSA) No Child I at Babind Ant (MICLE) - -- -- Continue Continue 4440 4 ESSA NCLB. All implementation of these by-laws and operation of the PBG PIAB shall be intended to comply with ESSA NCLB, related regulations and mandates from the U.S. Department of Education ("ISDF") and the Illinnis State Board of Education ("ISRE") These by laws may be emended unce

approval of the Chicago Board of Education.

ARTICLE II – GOVERNANCE

<u>Governance.</u> These by-laws and the guidelines to be prepared by the <u>Office of Family & Community Engagement in Education ("FACE2")</u> Office of Local School Council Relations shall govern the operation of the <u>PBG PIAB</u>.
